 - Dealer accepts full responsibility for all losses, damage, and injuries that may occur to themselves, associates, employees, family, guests, personal property, or merchandise for sale or trade. Dealer releases The North Atlanta Trade Center, Inc. and its employees and all individuals, companies, or corporations, that do business with The North Atlanta Trade Center, Inc. from any liability and losses, damage, or injuries.
 - Only items that are suitable to the character of an antique show will be shown. Pride of Dixie management reserves the right to remove any merchandise or dealers deemed inappropriate to the show and make final decisions on booth location.
 - The dealer expressly warrants that the goods sold to any purchaser are what the dealer represents they are. If the goods sold are not what the dealer represents they are, the dealer shall refund the full sales price to purchaser. If any purchaser brings a lawsuit in law or equity against management or its employees for any goods which are not what was represented at the sale through dealers intentional gross negligence or negligent conduct, dealer hereby agrees to indemnify management for any losses sustained by management from said action including attorney's fees.
 - Clearance, 50% off, close-out, and similar language signs are not permitted.
 - Dealer will not attach tacks, nails, or tape to any walls, posts, or fixtures.
 - Bring your own 50' electric cord. WE DO NOT FURNISH CORDS. All electric cords must be grounded.
 - In the event of a double-booked space, management will determine final space assignment.
 - All tables must be covered and all booths must be neat in appearance.
